- 1. Proof of Age/Identity:** Please provide one of the following (If your name is different from what's on your award letter, we'll need proof of your name change):
 - Birth Certificate
 - Passport
 - Driving Licence
 - Medical Card
- 2. Evidence of Disability:** (See the next page for details)
- 3. Proof of Residency:** Please include one of these documents, dated within the last three months or from the current year:
 - Utility Bill (gas, electricity, water)
 - Bank or Building Society Statement
 - Council Tax Bill
- 4. Recent Passport-sized Photo:** Please include one recent colour photo with your name and date of birth clearly written on the back.
